501 (c) 3 DISSOLUTION - Preparatory Action

<u>Below is an update of conversations, meetings and concerns held leading up to today's</u> <u>meeting, as well as discussions from the board meeting ...</u>

-Per Barb's conversation with David Horner, David expressed concern about falling under the MSU umbrella and how the possibility of future change in leadership at International Studies and Programs (ISP) would affect CVIP's status at MSU. Would CVIP still have support from new leadership?

-Will we have easy access to charitable donations?

- Concluded that we will do everything within legal parameters in dissolution and have full confidence in our funds falling under MSU.

<u>Draft of General Agreement with ISP</u>

Please note that Barb e-mailed the draft of this agreement to the board prior to our meeting on January 15. Presently, it is a framework to dissolution of CVIP's 501 (c) 3 status and is a work-in-progress in establishing and detailing ISP's and OISS' continued support of CVIP. This general agreement between CVIP and MSU-ISP will be sent to General Counsel. Stacey Bieler will prepare this document for final submission to General Counsel.

Per Barb's email, this draft is based upon several meetings with the Director of OISS, OISS staff, and ISP personnel with whom we would work after dissolving our nonprofit status and integrating as a subprogram under OISS within ISP. Conversation ensued at the meeting on specific language we want in this agreement and edits. I will try to highlight this conversation without re-writing the draft, as everyone has access to it.

#1 History of our organization

#2 What we do (our 8 programs)

#3 The 3 important funds to be overseen (Kumata Scholarship, Park Endowment, Higbee Endowment)

#4 There will no longer be a CVIP Board. ISP will formulate an Advisory Board to continue all oversight of our programs, including president, vice president, and secretary. Please note, a treasurer will no longer be needed.

#5 MSU-CVIP Scholarship Committee

#6 CVIP funds will be in OISS Operations account specifically for CVIP.

#7 OISS will continue to provide a liaison (Joy Shantz) to the MSU-CVIP Board. These tasks will make up 10% of this employee's job description.

#8 The parties intend to review this agreement "at minimum" every five years to evaluate the progress and quality of cooperation.

Dissolution attorney to cost est. \$1000

Action on 501 (c) 3 Dissolution

1. Motion to appoint and grant authority to CVIP Office Manager and Treasurer Bernard Pope, to work in conjunction with dissolution committee to wind down and dissolve the CVIP Corporation.
